## TERMS AND CONDITIONS

1. Customers are required to pay a fee for the use of an Access Card/Transponder.
2. If the Access Card/Transponder is lost, damaged or stolen, it will be the customer's responsibility to obtain another Access Card/Transponder from Cadillac Fairview. Customers will be charged the regular Access Card/Transponder fee plus all applicable taxes to replace Access Card/Transponder.
3. Parking charges plus all applicable taxes are payable in advance on the first day of each calendar month and are subject to interest charges at 2% per month (26.8% per annum) on any unpaid balance thereafter.
4. Parking charges are for the use of a parking space only. Cadillac Fairview is not responsible or liable for any injury, death, property damage, theft or disappearance occurring in, on or about the parking facility to the customer or anyone claiming under or through the customer.
5. Customers are subject to the terms and conditions displayed on all signs in the parking facility.
6. The customer must give one calendar month's written notice of termination (calendar month is from 1st day of the month to the last day of the same month). Parking charges will continue until the end of such month.
7. Terms, conditions and parking rates are subject to change with one month's written notice.
8. The customer cannot assign or transfer this agreement without the prior written consent of Cadillac Fairview which consent may be unreasonably withheld.
9. Cadillac Fairview reserves the right at any time and from time to time to refuse parking at the customer's normal location. Cadillac Fairview will use its reasonable best efforts to relocate the customer to another available Cadillac Fairview location if the customer's normal location is unavailable.
10. Failure to pay all parking charges when due will result in de-activation of the customer's Access Card/Transponder and denial of access to the parking facility. A re-activation fee will be levied once all outstanding charges are paid.
11. Customers must notify Cadillac Fairview as soon as possible of any change in their contact, banking or vehicle information.
12. No allowances will be made for vacations or other periods when the customer's vehicle is not in the parking facility.
13. Storage of vehicles in the parking facility is not permitted. Use of a parking space shall not exceed 48 consecutive hours. If stay exceeds 48 hours and the property management office has not given approval, parking fines are applicable.
14. **Privacy Statement:** Your privacy is very important to us. Your personal information collected on the Parking Agreement will only be used for parking purposes, and will remain confidential to The Cadillac Fairview Corporation Limited and its affiliates. It will however be disclosed to any company that acquires Cadillac Fairview, or some or all of its properties, provided that such company agrees to comply with our privacy policy. We may also use third parties to process some aspect of the information on our behalf, provided they agree to protect your privacy in the same manner as we do.
